L Drummond responded to say that yes, the time until engagement had been much slower than was anticipated and advised that the reasons for this were that the appointed sub committee had not been able to provide the Board with options in the time allocated and therefore the Chair and Executive Officer took over the role. The project is now underway with results due late January 2022.
